Dear Shareholder

A General Meeting (**Meeting**) of shareholders of Coda Minerals Ltd (ASX:COD) (**Company**) will be held at the offices of Blackwall Legal LLP at Level 26, 140 St George's Terrace, Perth, Western Australia at 9.30am (WST) on Tuesday, 7 February 2023.

The Board has made the decision that it will hold a physical Meeting with appropriate social distancing measures in place. Shareholders are also encouraged to provide an email address in order to receive electronic communication from the Company in the future.

Your proxy form must be received by 9.30am (WST) on Sunday, 5 February 2023 being not less than 48 hours before the commencement of the Meeting. Any proxy forms received after that time will not be valid for the Meeting.

Shareholders may submit questions in advance of the Meeting by email to the Company Secretary at info@codaminerals.com by 5.00pm (WST) on Friday, 3 February 2023. Shareholders who physically attend the Meeting will also have the opportunity to ask questions during the Meeting.

- (b) return both forms together.
