Notification under section 708A(5)(e) of the Corporations Act 2001 ("the Act")

Coda Minerals Ltd (ASX:COD) ("the Company") issued a total of 12,250,000 fully paid ordinary shares ("Shares") today. These Shares were included in an Appendix 2A announcement to the Australian Securities Exchange ("ASX") released today.
